

MCIA unveils the Young MCIA Steering Committee for 2023-2025

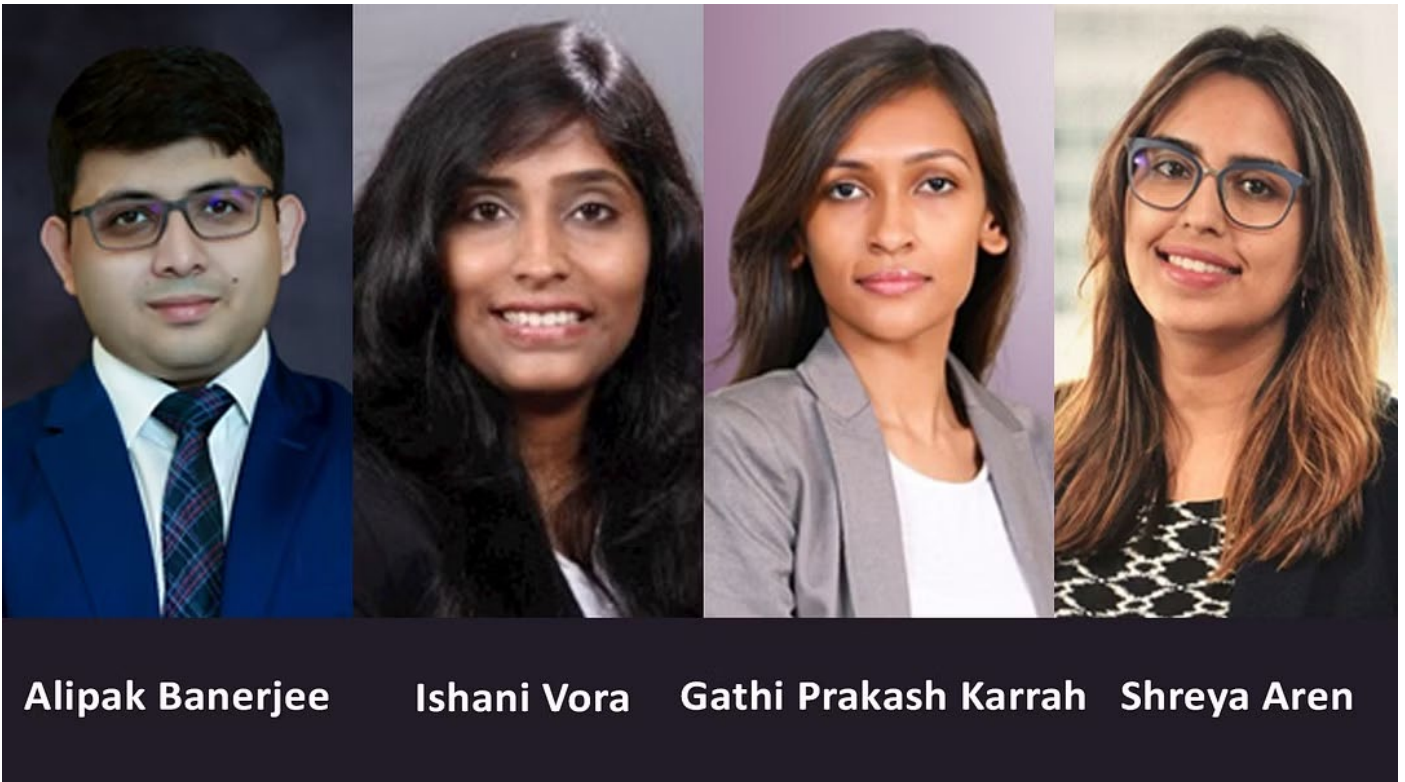
